INSTRUCTION

K-12 Keys for College and Career Readiness

Dr. Harris reviewed the final draft of the document that will be used with parents and staff to describe the initiative. This document provides targets, indicators, and the process for measuring achievement. This document will also be on the web site.

Dr. Harris used a PowerPoint presentation to explain the process used to develop the keys and to further explain what each key represents. The Board discussed the document and addressed these topics in particular:

- The matrix that will be used to indicate where progress is being made, a score card concept
- The current percent of students that are already reaching these targets
- Service projects; good citizenship, intentional interventions
- Dual credit and the status of discussions with COD on this issue

This document and the process to implement it and achieve the goals will be brought to the Board at the June 8 Board meeting for adoption.

Facility Update

Mr. Farley used a PowerPoint presentation to outline each of the district facilities and listing the current and future facility needs and things to consider down the road at each building.

There was a discussion about the Jefferson, Woodland, and SSC facilities. These three facilities have had no renovation work for many years. The Board discussed options for all three and different funding scenarios to pay for work that could be done above the routine maintenance.

Mr. Farley and Dr. Harris explained the option of Performance Based Contracting. This is a funding option that some school districts are taking advantage of where the energy savings pays for the work over time. The Board requested more information on this option. The Board also requested that information be brought to them per building that shows the work needed and the costs associated with the work. The Board would like to see a matrix analysis of options and a long term facility plan.

BOARD REPORTS

IASB Resolutions

Annually, the IASB holds their state conference in November. At the conference, the delegate assembly meets to review and vote on the resolution proposals. Members Intihar and Vroman presented three such proposals for the Board to consider for submission to the IASB Delegate Assembly. Three proposals were brought forward that address the following areas:

- The consolidation of elementary districts with high school districts to make K-12 districts
- The ability for Boards of Education to take action on reduction in force after state budget allocations are known
- Support for legislation to implement the addition of interest to late state payments

The Board discussed the proposed resolutions. Board members were asked to submit to Member Intihar, any suggestions for changes to the wording. These resolutions will be voted on at the June 8, 2011 Board meeting.
