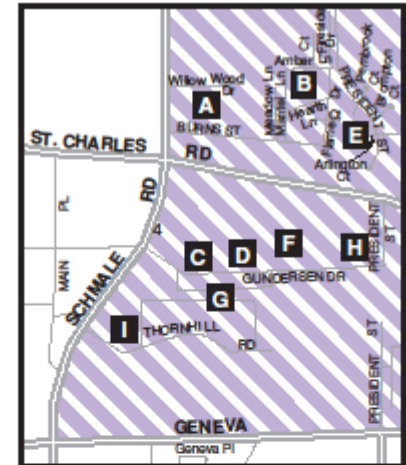
# Background

- Fall 2014 – Enrollment Committee identified an enrollment strategy concern at **Hawthorne** and **Pleasant Hill** Elementary Schools.
- Several years ago, **Hawthorne** experienced a growth in enrollment.
  - *New families* from Covered Bridges enrolling in the District were asked to enroll at Pleasant Hill Elementary.
  - However, *new students of existing* Hawthorne families were able to continue enrolling at Hawthorne.



# Background

- According to the current District 200 boundary map, students who live in the Covered Bridges Apartments *should* attend **Hawthorne**.



Students who live in the area east of Schmale Road and north of Geneva Road are assigned as noted:

# The Current Scenario

- There are approximately 150 students from Covered Bridges.
  - Approximately 100 attend Pleasant Hill ( $\frac{2}{3}$ )
  - Approximately 50 attend Hawthorne ( $\frac{1}{3}$ )
- The enrollment distribution of students is currently manageable for both schools.
- Neither building can accommodate the *entire* student population from Covered Bridges.



# The Challenge

Without any change in student assignment:

- All students from Covered Bridges would eventually attend Pleasant Hill.
- The school could not accommodate this increase in enrollment.



# The Options

1. Maintain current enrollment structure
2. Assign students each year as they enroll
3. Adjust the current boundary to distribute future enrollment between two buildings



# Community Engagement

- District staff reviewed options with several stakeholder groups to solicit feedback.
  - Covered Bridges families and management
  - Pleasant Hill families and staff
  - Hawthorne families and staff
- The Enrollment Committee met January 8<sup>th</sup> to review the recommendation and provide feedback.

# Administrative Recommendation

- The complex will be divided into a west section and an east section.
- The proposed recommendation will not affect any *current* Hawthorne or Pleasant Hill families.

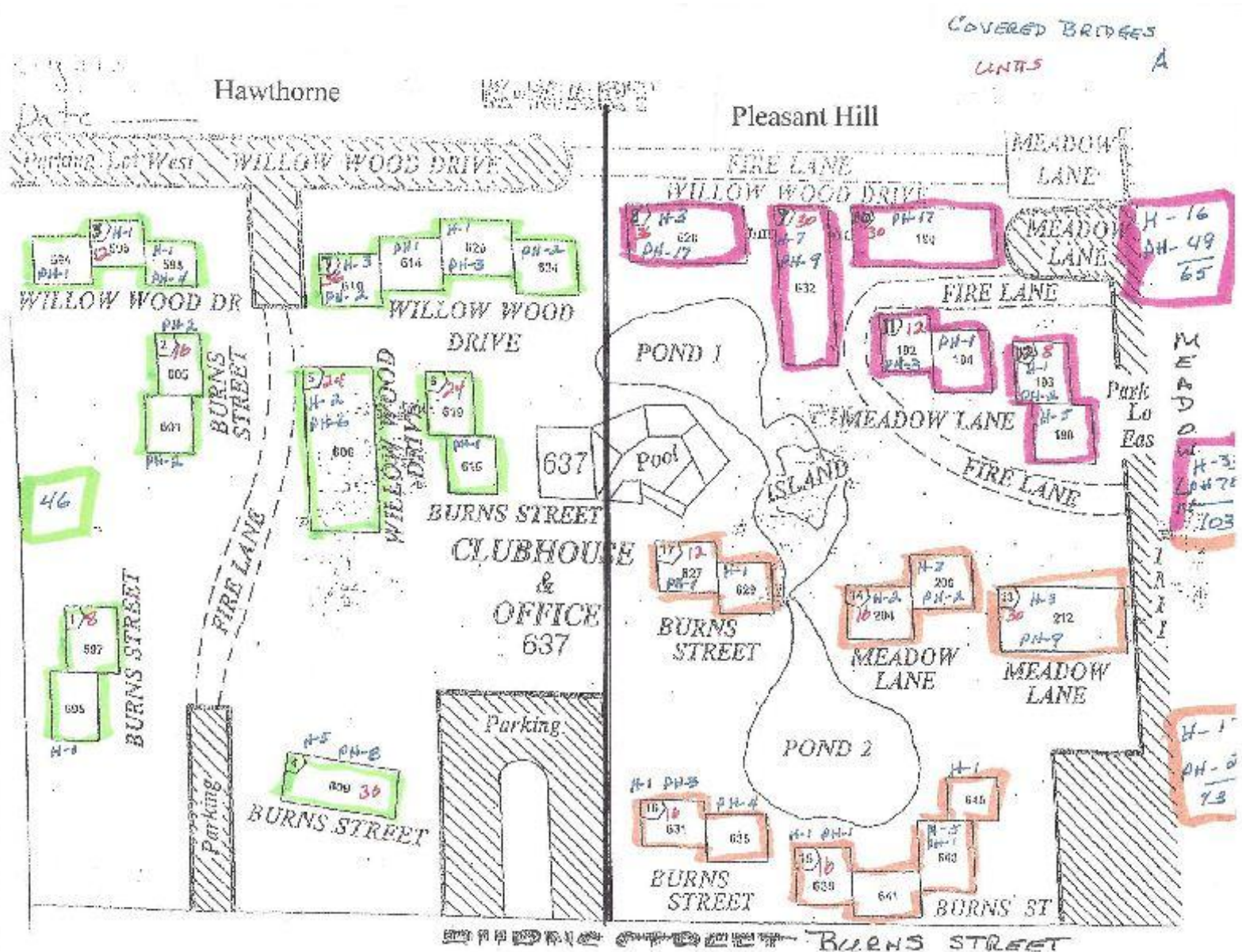


# Administrative Recommendation

- **The west section will attend Hawthorne Elementary.**
  - Contains approximately  $\frac{1}{3}$  of the student population from Covered Bridges
  - Students will continue to Franklin Middle School
- **The east section will attend Pleasant Hill Elementary**
  - Contains approximately  $\frac{2}{3}$  of the student population from Covered Bridges
  - Students will continue to Monroe Middle School

# Administrative Recommendation

- Any new families from Covered Bridges that enroll in District 200 will be asked to follow the proposed boundary line.
- Existing Hawthorne and Pleasant Hill families will remain at their current school.
- Any new students from existing families will be able to enroll at the same school as their sibling(s).
